

An Ordinance vacating that part of Nineteenth Street in the City of Portland in Multnomah County, Oregon, lying between the southerly side line of Market Street and of Market Street Drive and a line drawn east and west across said Nineteenth Street from the southwest corner of Lot Seven (7) in Block One (1) in Market Street Addition to the City of Portland to the southeast corner of Lot Two (2) in Block Two (2) in said Market Street Addition, excepting a strip four feet wide on each side of the center line of said Nineteenth Street the full length of said part of said street sought to be vacated.

WHEREAS due notice was given, by advertisement thereof, for more than four consecutive weeks, to-wit; from the 18th day of March, 1911, to the 15th day of April 1911, inclusive, in the official newspaper of the City of Portland, Oregon, to-wit: The Daily Abstract, published in said City, that at a regular meeting of the Council of said City to be held on Wednesday the 25th day of April, 1911, a petition would be presented to said Council praying for the vacation of that part of Nineteenth Street in said City of Portland lying between the southerly side line of Market Street and of Market Street Drive and a line drawn east and west across said Nineteenth Street from the southwest corner of Lot Seven (7) in Block One (1) in Market Street Addition to the City of Portland to the southwest corner of Lot Two (2) in Block Two (2) in said Market Street Addition, except a strip four feet

wide on each side of the center line of said Nineteenth Street the full length of said part of said street so to be vacated, which said notice with proof of its publication is filed in the office of the Auditor of said City of Portland, together with said petition. And

WHEREAS said petition was duly presented to said Council on the 26th day of April, 1911, and said petition duly set forth a description of that part of said Nineteenth Street sought to be vacated and the purpose for which the ground is proposed to be used and the reason for such vacation, to which there was appended as a part thereof and as a basis for such vacation and as a basis for the granting of the prayer of said petition the consent of the owners in fee simple of all of the real estate fronting on that part of said Nineteenth Street sought to be vacated, as well as the consent of the owners of more than two-thirds of all of the real property fronting on both sides of said Nineteenth Street within and for a distance of two hundred feet in each direction from the termini of that part of said Nineteenth Street proposed to be vacated, which consent of said owners was duly acknowledged before Notaries Public for the State of Oregon and filed with the Auditor of the City of Portland, Oregon, all as required by the charter of said City; and

WHEREAS the said Council after the filing and presentation of said petition and the filing of the proof of the publication of said notice did fix the regular meeting of said Council on Wednesday the 14th day of June, A. D., 1911, at the regular time and place as the time for hearing said petition and any objections thereto; and

WHEREAS the remonstrance or objection to said vacation filed with the Auditor of said City of Portland by John Munster and others has been read and considered by said Council and said remonstrance or objection to such vacation has been determined and overruled by said Council. And

WHEREAS said Council has ascertained and determined, and does hereby cause it to be made a matter of record that all of the hereinbefore recited acts and things have been done and that the consent of the owners of the requisite number of front feet of the real estate fronting on said Nineteenth Street and on the part thereof sought to be vacated, required by the charter of said City, has been duly obtained and that the public interest would not be prejudiced by the vacation of that part of Nineteenth Street aforesaid sought to be vacated, and the said Council so finding; NOW THEREFORE

The City of Portland does ordain as follows:

Section 1: That that part of Nineteenth Street in said City of Portland lying between the southerly side line of Market Street and of Market Street Drive and a line drawn east and west across said Nineteenth Street from the southwest corner of Lot Seven (7) in Block One (1) in Market Street Addition to the City of Portland to the southeast corner of Lot Two (2) in Block Two (2) in said Market Street Addition, except a strip four feet wide on each side of the center line of said Nineteenth Street the full length of said part of said street sought to be vacated, be, and the same hereby is vacated.
