ORDINANCE No. 111833

An Ordinance accepting an easement in Sections 20 and 21, T.1N., R.1E., W.M., granted by Efem Warehouse Company, for the N. Basin Avenue and Mock's Bottom Storm and Sanitary Sewer System, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described easement granted for the N. Basin Avenue and Mock's Bottom Storm and Sanitary Sewer System, be and is hereby accepted for sewer purposes:

A strip of land 20.0 feet in width, 10.0 feet on either side of the following described center line in Sections 20 and 21, T.1N., R.1E., W.M.;

Commencing at the intersection of the center lines of N. Basin Avenue and N. Webster Street; thence S. 35°41'E. along the center line of said N. Basin Avenue 23.0 feet; thence S. 48°58' W.40.18 feet to the west line of N. Basin Avenue and the true point of beginning of the 20.0-foot strip herein described; thence continuing S.48°58' W. to the East Harbor Line of the Willamette River; all within the corporate limits of the City of Portland, County of Multnomah and State of Oregon.(Granted by Efem Warehouse Company, c/o Fred Meyer, Inc., 721 S.W. 4th Avenue, Portland 4, Oregon).

Section 2. That the City Auditor be and he is hereby directed to have this easement, as described in Section 1 of this ordinance, placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any undue delay in making this right-of-way a matter of record; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
