ORDINANCE No. 112591

An Ordinance authorizing and directing the Purchasing Agent to advertise for and receive proposals for furnishing 10% D.D.T. solution for the Bureau of Insect Control during the calendar year 1961, authorizing a contract therefor, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Purchasing Agent is hereby authorized and directed to advertise for and receive proposals for furnishing 10% D.D.T. solution for the Bureau of Insect Control, all in accordance with specifications filed in the Bureau of Purchases, September 19, 1960, which specifications are hereby adopted.

Section 2. The Mayor and the Auditor are hereby authorized to enter into a contract with the lowest responsible bidder for furnishing 10% D.D.T. solution for the Bureau of Insect Control; provided, however, that the Council reserves the right to reject any or all bids, in whole or in part; and that in case no bids are received which are satisfactory to the Council, the Purchasing Agent is hereby authorized to advertise therefor such number of times as may be necessary to receive satisfactory bids. Payment for said 10% D.D.T. solution shall be made out of the General Fund, appropriation Bureau of Insect Control, Mosquito Division, Botanical and Agricultural, Code No. 2560.210.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Fortland in this: In order that the 10% D.D.T. solution may be available when needed; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
