ORDINANCE NO. 115209

An Ordinance accepting a sewer easement through Lot 4, Tract E, Northrop Acres, granted by Helen Anderson, recorded owner, and Ted B. Bell and Joann E. Bell, contract purchasers, for the Tryon Creek Interceptor Sewer, authorizing the drawing and delivery of a warrant, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described sewer easement, granted for the Tryon Creek Interceptor Sewer, be and is hereby accepted for sewer purposes:

That portion of Lot 4, Tract E, Northrop Acres, lying within a strip of land 15.0 feet in width, 7.5 feet on either side of the following described center line:

Beginning at a point in the south line of Lot 4, Tract E, Northrop Acres, 0.53 feet west of the southeast corner thereof; thence N. 06° 17' 51" W. 53.87 feet to a point in the east line of said Lot 4, 53.93 feet north of the southeast corner thereof; thence continuing N. 06° 17' 51" W. through Lots 6, 5 and 4 of Tract B, Northrop Acres, 233.71 feet to a point in the east line of Lot 3 of Tract E, Northrop Acres, 8.69 feet northeasterly of the southeast corner of said Lot 3 in the County of Multnomah and State of Oregon. (Granted by Helen Anderson, 6011 S.E. Powell Boulevard, and by Ted B. Bell and Joann E. Bell, 1352 S.W. Taylors Ferry Court).

During the construction of said sewer the City is granted the privilege to use mechanical equipment for digging, hauling, unloading and temporarily storing materials on said grantor's property within 15 feet of the side-lines of said permanent easement. Payment for damage to any portion of the grantor's property lying outside the permanent easement hereinabove mentioned shall be provided for in the same manner as is provided for payment for damages within said permanent easement.

Section 2. The Mayor and Auditor be and they hereby are authorized to draw and deliver a warrant in favor of Ted.B. Bell and Joann E. Bell, in the amount of \$119.00 in payment for the sewer easement as described in Section 1 of this ordinance, said warrant shall be chargeable to the Tryon Creek Sewage Disposal Construction Fund, 6351-765, per written authorization from Helen Anderson.

Section 3. That the City Auditor be and he is hereby directed to have this easement, as described in Section 1 of this ordinance, placed on record.

Section 4. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland
