ORDINANCE NO. 115236

An Ordinance amending Ordinance No. 115157, passed by the Council May 3, 1962, which granted a revocable permit to Southern Pacific Pipe Lines, Inc. to lay, use and maintain pipe lines for transporting petroleum products in a certain area of the City, so as to permit changes in detailed maps with approval of the City Engineer, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that by Ordinance No. 115157, passed by the Council May 3, 1962, a revocable permit was granted to Southern Pacific Pipe Lines, Inc. pending negotiations for a franchise with the City to lay, use and maintain pipe lines in N.W. St. Helens Road and certain connecting streets between N.W. Express Street and N.W. 113th Avenue, for the purpose of transporting petroleum products; that said ordinance provided that construction should be in accordance with Exhibit hA" attached to the ordinance, setting forth the plan and also in accordance with detailed supplemental maps filed with the City Engineer; that it now appears that said detailed supplemental maps should be changed and may require additional subsequent changes in order to provide protection to existing utility lines in the street area according to their location determined by subsequent investigation and during the process of construction; that therefore an additional condition should be added to Section 1 of said ordinance to permit such changes; now, therefore, Section 1 of Ordinance No. 115157, entitled: " An Ordinance granting a revocable permit to Southern Pacific Pipe Lines, Inc., pending negotiation of a franchise with the City of Portland, to lay, use and maintain pipe lines 8 inches in diameter, in, under, and across N.W. St. Helens Road and certain connecting streets between N.W. Express Street and N.W. 113th Avenue, for the purpose of transporting petroluem products under certain conditions, and declaring an emergency." passed by the Council May 3, 1962, hereby is amended by adding thereto, a new paragraph at the end thereof to be lettered and to read as follows:

(o) In the event construction plans need to be revised or changed in the judgment of the City Engineer in order to afford protection to existing utility lines, found to be located nearby or adjacent to the pipe lines permitted hereunder, the City Engineer with the concurrence of engineers in charge of such utility lines may approve changes in construction plans of the grantee but such changes shall be shown on detailed supplemental maps which shall be filed with the City Engineer, and which may be substituted with the approval of the City Engineer for the detailed supplemental maps mentioned in this ordinance as already filed.

ORDINANCE No.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that construction plans may proceed without unnecessary delay for the laying of the pipe lines permitted under Ordinance No. 115157, this ordinance should take effect immediately; therefore an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
