ORDINANCE No. 118021

An Ordinance transferring \$225.00 withen the General Fund from appropriation Emergency and Unforeseen Expenditures to the office of the Commissioner of Public Affairs for the purchase of an arm chair, not budgeted, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that there is need of an arm chair in the office of the Commissioner of Fublic Affairs that the cost of the arm chair is estimated to be \$225.00, that there is no provision within the current budget for the purchase of said arm chair; and that authority and appropriation should be made available for the purchase of this equipment; now, therefore, the sum of \$225.00 is hereby transferred within the General Fund from appropriation Emergency and Unforeseen Expenditures (4100) to the appropriation Office of the Commissioner of Public Affairs, Equipment (1600.720) for the purchase of an arm chair.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Fortland in this: In order that authority and appropriation maybe provided for the purchase of the chair described in Section 1 above without delay; therefore, an emergency hereby is declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
