## ORDINANCE NO. 119940

An Ordinance accepting a Relinquishment of Title to certain parcels of property relinquished by the State of Oregon, by and through its State Highway Commission to comply with the terms of that certain agreement in connection with the widening of S.W. Front Avenue between S.W. Harrison Street and S.W. Grant Street, entered into between the State Highway Commission and the City of Portland on July 14, 1964, and declaring an emergency.

The City of Portland ordains:

Section 1. The following described parcels of land are hereby accepted for street purposes:

Parcel A. Those portions of Blocks 106 and 107, City of Portland, State of Oregon, lying within the following described parcel of land:

Commencing at a point in the northerly line of said Block 107, which point is also the southwesterly corner of Block J, South Auditorium Addition, in the City of Portland; thence westerly along the northerly line of said Block 107, a distance of 40 feet to the northwesterly corner of said Block 107 and the true point of beginning of the parcel herein described; thence South 20° 49' 25" West, along the westerly line of Blocks 107 and 106, a distance of 332.81 feet to the southwesterly corner of said Block 106; thence South  $0^{\circ}$  41' 57" West, along the westerly line of Blocks A and B, Caruthers Addition to Caruthers Addition, in the City of Portland, a distance of 284.23 feet; thence northerly along the arc of a 2711.60 foot radius curve to the right (the long chord of which bears North 10 47' 36" East, 103.56 feet) a distance of 103.57 feet to a point of compound curve; thence northeasterly along the arc of a 970.10 foot radius curve to the right (the long chord of which bears North 11° 51' 20" East, 302.45 feet) a distance of 303.68 feet to a point of tangency; thence North 20° 49' 25" East, 203.03 feet to a point in the northerly line of said Block 107, City of Portland; thence westerly along the northerly line of said Block 107, a distance of 16.90 feet to the true point of beginning, containing 6,100 square feet.

And, only so long as used for public street purposes, all right, title and interest of the State in and to the following described Parcel B, being an  $undivided\ 4/10\ interest$ , to wit:

<u>Parcel B.</u> Those portions of Blocks A and B, Caruthers Addition to Caruthers Addition, in the City of Portland, State of Oregon, lying within the following described parcel of land:

Commencing at a point in the northerly line of Block 107, in the City of Portland, which point is also the southwesterly corner of Block J, South Auditorium Addition, in the City of Portland; thence westerly along the northerly line of said Block 107, a distance of 40 feet to the northwesterly corner of said Block 107 and the true point of beginning of the parcel herein described; thence South 20° 49' 25" West, along the westerly line of Blocks 107 and 106, in the City of Portland, a distance of 332.81 feet to the southwesterly corner of said Block 106; thence South 0°41'57"

West, along the westerly line of Blocks A and B, Caruthers Addition to Caruthers Addition, a distance of 284.23 feet; thence northerly along the arc of a 2711.60 foot radius curve to the right (the long chord of which bears North 1° 47' 36" East, 103.56 feet) a distance of 103.57 feet to a point of compound curve; thence northeasterly along the arc of a 970.10 foot radius curve to the right (the long chord of which bears North 11° 51' 20" East, 302.45 feet) a distance of 303.68 feet to a point of tangency; thence north 20° 49' 25" East, 203.03 feet to a point in the northerly line of said Block 107, City of Portland; thence westerly along the northerly line of said Block 107, a distance of 16.90 feet to the true point of beginning, containing 1,860 square feet.

To Have and To Hold, title to the said premises with their appurtenances unto the said City of Portland, its successors and assigns, only so long as used for public street purposes.

Section 2. That the City Auditor be and is hereby directed to have the Relinquishment of Title placed on record, and a copy of this ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any undue delay in making this right of way a matter of record; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
