ORDINANCE NO. 124421

An Ordinance authorizing the purchase of Lots 1,2,3,4, and 5, Block 50, Peninsular Addition No. 4 to East Portland, located on N. Columbia Boulevard at N. Wilbur Avenue from Realty Finance Co., 308 S.W. Washington Street, Portland 97204, for the sum of \$9000 plus a proportionate share of the current real property taxes, authorizing the drawing and delivery of warrants, and declaring an Emergency.

The City of Portland ordains:

Section 1. The Council finds that it is necessary and desirable to purchase Lots 1,2,3,4 and 5, Block 50, Peninsular Addition No. 4 to East Portland, located on N. Columbia Boulevard at N. Wilbur Avenue, in connection with the proposed widening of N. Columbia Boulevard; that Realty Finance Co. as owner of the property has offered to sell the same to the City for the sum of \$9000, which is a fair and reasonable price; that such purchase should be authorized; now, therefore, purchase of Lots 1,2,3,4 and 5, Block 50, Peninsular Addition No. 4, to East Portland, Multnomah County, Oregon, from Realty Finance Co. 308 S.W. Washington Street, Portland 97204, for the sum of \$9000, hereby is authorized.

Section 2. The Mayor and Auditor hereby are authorized to draw and deliver the following warrants in payment of the purchase price and a proportionate share of current real property taxes on said property, such warrants shall be drawn against and charged to the Capital Improvements Fund appropriation Purchase of Property (6695. 780):

- a. Warrant in the sum of \$65, payable to Title Insurance Co., 425 S.W. 4th Avenue, Portland 97204, as payment for the preliminary title report and title insurance policy in the sum of \$9000.
- b. Warrant in the sum of \$9.90 payable to the United States Postmaster as payment for the required revenue stamps to be affixed to the deed to the City.
- c. Warrant in the sum of \$338. 23, payable to Multnomah County Tax Collector as payment for 1965-1966 and 1966-1967 real property taxes, plus interest thereon.
- d. Warrant in the sum of \$8613.33, payable to Realty Finance Co. 308 S.W. Washington Street, Portland 97204; said warrant represents the purchase price less cost of title insurance, the federal revenue stamps and the 1965-1966 and 1966-1967 real property taxes plus interest thereon, plus the City-s pro-rata share of the 1966-1967 real property taxes in the sum of \$26.46. Said warrant to be delivered to Seller upon receipt of a good and sufficient deed, approved as to form by the City Attorney.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the property purchase authorized in Sction 1 hereof for the widening of N. Columbia Boulevard may be accomplished without unnecessary delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
