ORDINANCE No. 125126

An Ordinance authorizing and directing R.A. Niedermeyer and Paul L. Miller, Bureau of Buildings, to attend the annual meeting of Northwest Section of International Association of Electrical Inspectors in Boise, Idaho, September 17-20, 1967, authorizing expenses in the total sum of \$332.40, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the annual meeting of the Northwest Section of International Association of Electrical Inspectors will be held in Boise, Idaho, September 17 through September 20, 1967; that R.A. Niedermeyer, Chief Electrical Inspector, and Paul L. Miller, Assistant Chief Electrical Inspector, have been selected to attend; that it would be in the interests of the residents of the City that said representatives of the City attend, and that their expenses be paid; now, therefore, R.A. Niedermeyer and Paul L. Miller hereby are authorized and directed to attend the Northwest Section of the International Association of Electrical Inspectors meeting to be held in Boise, Idaho, September 17 through September 20, 1967, and the Mayor and Auditor hereby are authorized to draw and deliver warrants in the sum of \$166.20, payable to said R.A. Niedermeyer and Paul L. Miller, said warrants to be charged to the appropriation Travel and Employee Education (5035). Each employee shall file an accounting of expenses with the City Auditor, and shall refund to the City Treasurer any moneys remaining from the appropriation herein mentioned.



Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that necessary arrangements may be made in ample time for said meeting; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
