ORDINANCE No. 125126

An Ordinance authorizing and directing R.A. Niedermeyer and Paul L. Miller, Bureau of Buildings, to attend the annual meeting of Northwest Section of International Association of Electrical Inspectors in Boise, Idaho, September 17-20, 1967, authorizing expenses in the total sum of \$332.40, and declaring an emergency.

The City of Portland ordains:

Section 1.
