## ORDINANCE No. 129867

An Ordinance amending Ordinance No. 124922 granting a revocable permit to the State of Oregon to construct and maintain a pedestrian bridge over and across SW Harrison Street and SW Broadway in the vicinity of their intersection, and declaring an emergency.

The City of Portland ordains:

Section 1. It appearing to the Council that Ordinance No. 124922 entitled "An Ordinance granting a revocable permit to the State of Oregon to construct and maintain a pedestrian bridge over and across SW Harrison Street and SW Broadway in the vicinity of their intersection and declaring an emergency" was in error in that it contained a hold harmless clause that cannot be accepted by the State, that said clause should be replaced by a clause requiring insurance, therefore, Ordinance No. 124922 is hereby amended by deleting in its entirety Subsection (d) of Section 1 and replacing it with the following subsection:

(d) The grantee shall protect the City of Portland, its officers, agents and employees by suitable insurance in the amount of \$100,000 for any single injury, \$300,000 for any one accident and \$50,000 property damage, said insurance to be kept in full force and effect at all times and this permit revoked without further action by the Council if said insurance is permitted to lapse, or for any reason lapse, or be cancelled or for any other reason become inoperative.

Section 2. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the insurance may be required without undue delay; therefore, an emergency is hereby declared to exist and this Ordinance shall be in force and effect from and after its passage by the Council.
