ORDINANCE No. 130236

An Ordinance authorizing the employment of Margaret K. Rennie, from time to time on a short-term temporary basis as a Sr. Stenographer Clerk at Step G of the salary range for Sr. Stenographer Clerk, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Margaret K. Rennie, will be employed from time to time on a short term temporary basis in various offices of the City as a Sr. Stenographer Clerk; that the first such employment will be in the Office of the Commissioner of Public Utilities for five days: January 5,6,7, January 16 and January 19, 1970; that such employe is a retired Sr. Stenographer Clerk who was at the time of retirement at the maximum salary for this class; that because of her previous experience which is extremely valuable in any short term employment, she should be paid at the maximum salary for Sr. Stenographer Clerk whenever her services are required; now, therefore, the employment of Margaret K. Rennie at the maximum salary for Sr. Stenographer Clerk for short periods of time as needed hereby is authorized at the maximum rate of pay for the class of Sr. Stenographer Clerk, as provided in the current Compensation Plan.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the salary authorized in Section 1 hereof for said employe will be effective by the date of employment; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
