ORDINANCE No. 135827

An Ordinance authorizing the Mayor and Auditor to execute and deliver a quitclaim deed releasing the interests of the City in a portion of Lot 2, Block 17, Kings Heights, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that by Sheriffs Deed dated May 29, 1920, and recorded in Book 847 at Page 31, Multnomah County Deed Records, Multnomah County conveyed to the City of Portland various parcels of property located throughout the City; that such conveyance included that portion of Lot 2, Block 17, Kings Heights, lying southerly of NW Monte Vista Terrace, said portion containing 12 square feet, more or less; that such City-owned portion of Lot 2 eliminates street frontage to a residence located at 2820 NW Monte Vista Terrace, and the owner of said residence has requested the City quitclaim its interest in said 12 square foot parcel to provide continuous street frontage to the residence; that such parcel is of such small size as to have little, if any, monetary value; that such request is reasonable and should be granted, and the City Engineer and Commissioner of Public Works recommends the request be granted; now, therefore, the Mayor and Auditor are hereby authorized and directed to execute and deliver to Mr. Barton F. Baker, 2820 NW Monte Vista Terrace, Portland, Oregon, a quitclaim deed, approved as to form by the City Attorney, conveying to Barton F. Baker and Anna Louise Baker, husband and wife, the interests of the City in and to property described as follows, to wit:

That portion of Lot 2, Block 17, Kings Heights, lying southerly of NW Monte Vista Terrace as now laid out and established in the City of Portland, County of Multnomah and State of Oregon.

Section 2. Inasmuch as this ordinance is necessary for the immediate health, peace and safety of the City of Portland in this: in order that there be no delay in conveying City-owned property to provide continuous street frontage for residential property, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
