An Ordinance amending the Compensation Plan of the City of Portland to adjust the salary rate for Classification No. 5257, Management Support Services Officer in the Bureau of Fire, effective February 24, 1978, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That classification specifications for the Management Support Services Officer position have been revised;
