# **ORDINANCE No. 151690**

An Ordinance amending Title 14, Public Peace, Safety & Morals, of the Code of the City of Portland by enacting a provision, as a part of Chapter 14.08, Enforcement, which prohibits camping in certain public places,

The City of Portland ordains:

### Section 1. The Council finds:

- 1. That from time to time persons establish campsites, for the purpose of maintaining a temporary place to live, on sidewalks, public rights of way, under bridgeways, and so forth.
- 2. That such persons, by such actions, are creating unsafe and unsanitary living situations which pose a threat to the peace, health and safety of themselves and other citizens of the City.

## NOW, THEREFORE, the Council directs:

a. That Title 14, Public Peace, Safety and Morals, Chapter 14.08, Enforcement, of the Code of the City of Portland, is hereby amended by enacting the following new section:

14.08.250 Camping prohibited in certain places. (a) As used in this section:

(1) "to camp" means to attempt to set up, or to set up, or to remain in or at, a campsite.

(2) "campsite" means any place where any bedding, sleeping bag or other sleeping matter, or any stove or fire, are placed, established or maintained, whether or not such place incorporates the use of any tent, lean-to, shack or any other structure, or any vehicle or part thereof.

(b) It is unlawful for any person to attempt to camp, or to camp, or to build or maintain any fire, in or upon any sidewalk, street, alley, lane, public right of way or any other place to which the general public has access, or under any bridgeway or viaduct, unless otherwise specifically authorized by this code.
