

ORDINANCE NO. 157952

An Ordinance authorizing the drawing and delivery of a warrant in the amount of \$435.00 payable to Katherine N. Wheeler, (Neighborhood Flag Project Director) for settlement of a claim which has been investigated by the Committee on Claims recommending denial which was amended and approved for payment by the City Council, providing for release, and declaring an emergency.

The City of Portland ordains:**Section 1: The Council finds:**

1. That Katherine N. Wheeler, Neighborhood Flag Project Director, has made a claim against the City, which claim has been investigated by the Committee on Claims.
2. That the Committee on Claims, by report to the City Council dated October 16, 1985, has recommended denial of this claim.
3. That the City Council, on October 30, 1985, Council Calendar No. 2150 by motion amended the report of the Committee on Claims, thereby approving this claim, and directed that this claim be settled.

NOW, THEREFORE, the Council directs:

- a. That the Mayor and the Auditor are hereby authorized to draw and deliver a warrant to the claimant in the amount of \$435.00, said warrant to be drawn and charged to the: General Fund, Indemnities, BUC 41500506; Expense Code 490.

Section 2: The Council declares that an emergency exists because there should be no unnecessary delay in meeting the financial obligations of the City; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
