

ORDINANCE No. 158366

An Ordinance amending Title 14, Public Peace, Safety and Morals of the Code of the City of Portland, by the addition of a subsection to Section 14.24.030, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Chapter 14.24, Maintaining Public Order, contains sections which make consumption of alcoholic liquor upon any street, sidewalk or other public right of way unlawful.
2. The Office of the City Engineer currently issues permits for placement of sidewalk cafes in public rights of way.
3. The consumption of alcoholic liquor in permitted sidewalk cafes is a normal function of these establishments.
4. The consumption of alcoholic liquor within permitted sidewalk cafes poses little impact upon maintaining public order.

NOW THEREFORE, THE COUNCIL DIRECTS:

- a. Section 14.24.030 of Title 14 of the Code of the City of Portland is hereby amended by the addition of subsection (c), which shall read as follows:

(c) This section does not apply to prohibit the consumption of alcoholic liquor in sidewalk cafes which have been issued permits under Chapter 17.25 of this Code.

Section 2. The Council declares that an emergency exists in order to avoid unnecessary delay in the issuance of sidewalk cafe permits, therefore; this Ordinance shall be in force and effect from and after its passage by the Council.
