

RESOLUTION No. 36822

Place Firefighter Memorial Plaza in the jurisdiction of Portland Parks & Recreation for enforcement purposes (Resolution)

WHEREAS, the Portland Bureau of Transportation owns and maintains Firefighter Memorial Plaza; and

WHEREAS, the general public uses Firefighter Memorial Plaza, not only for pedestrian transportation, but also as a gathering place, similar to a plaza in a public park; and

WHEREAS, such use by members of the public creates public safety challenges that are appropriately addressed in parks settings through regulation and enforcement under Chapter 20.12 of the City Code, and, in particular, through the warning and exclusion provisions of Section 20.12.265; and

WHEREAS, the Portland Police Bureau desires that the City's park regulations be applied to the Firefighter Memorial Plaza;


NOW, THEREFORE, BE IT RESOLVED, that Firefighter Memorial Plaza, as depicted in Exhibit A to this Resolution, is hereby placed within the jurisdiction of Portland Parks & Recreation for parks and recreation purposes, and the provisions of Chapter 20.12 of the City Code shall apply to conduct in Firefighter Memorial Plaza; and

BE IT FURTHER RESOLVED, the Bureau of Transportation shall have jurisdiction of Firefighter Memorial Plaza for transportation purposes, including enforcement of transportation regulations, and the City's maintenance responsibilities for the public areas and improvements in Firefighter Memorial Plaza shall continue to be assigned to the Bureau of Transportation.
