Repeal Ordinance No. 151741 in its entirety and remove any setback requirements established by the Ordinance on the eastside of SW Moody Ave from SW Sheridan St to SW Woods St (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 151741 was passed by Council on June 11, 1981 establishing a 15-foot setback line on the east side of SW Moody Avenue from SW Sheridan Street to SW Woods.
- 2. These setbacks were established in anticipation of the Willamette Greenway Bike Route, a portion of which is currently under construction in the SW Moody Avenue relocation project. Exhibit A depicts the relocation project and Exhibit C depicts the cross section of the streetscape.
- 3. Portions of the alignment of SW Moody Avenue are being relocated to the West providing access for streetcar, light rail, bikes, pedestrians and motor vehicle traffic. As a result, the current right-of-way and property acquired to the west are sufficient to accommodate the multi-modal use of SW Moody Avenue, and the setbacks retained in Ordinance No. 151741 will not be necessary to accomplish the transportation goals of the City of Portland.
- 4. The Portland Development Commission, the Bureau of Planning and Sustainability and the affected property owners support the new alignment and the removal of the setback requirements.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 151741 is repealed in its entirety and any and all setback requirements established by the Ordinance are hereby removed.
