*Amend contract with Parametrix, Inc., to extend contract date, add services and increase compensation to prepare a Parking Management Plan for the Central Eastside Industrial District (Ordinance; amend Contract No. 30001283)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On May 1, 2010, the Bureau of Transportation entered into Contract No. 30001283 with Parametrics, Inc. for \$177,515 to prepare a Parking Management Plan for the Central Eastside Industrial District.
- 2. The Scope of Work for Parking Management Plan is being modified to provide additional services to assist with project management and with the various functions of coordinating and supporting the Stakeholder Advisory Committee and the Public Workshops.
- 3. The contract expiration date is being extended from April 30, 2010 to December 31, 2011.
- 4. The compensation for the additional services will not exceed \$95,000.
- 5. The Bureau's level of confidence in the cost estimates for this project is moderate

NOW, THEREFORE, the Council directs:

a. That the Commissioner-in-Charge and the Auditor are authorized to amend Contract No. 30001283 with Parametrics, Inc., to extend the expiration date to December 31, 2011 and increase the compensation by an amount not to exceed \$95,000.

Section 2. The Council declares an emergency exists because this is a currently ongoing project and the additional services are immediately needed; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
