\* Amend an Intergovernmental Agreement with Multnomah County, acting by and through its District Attorney's Office to reimburse for Police Bureau overtime costs on after-hours call-outs on child abuse investigations (Ordinance; amend Contract No. 30001158)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The CAMI Grant provides funding from the Child Abuse Multi-disciplinary Intervention Account to Multnomah County District Attorney's Office (MCDA) in accordance with the grant application and awards.
- 2. The Police Bureau provides Detectives specially trained in conducting child abuse investigations including evening hours and on weekends to respond to child abuse referrals.
- 3. The MCDA agrees to reimburse the Police Bureau for overtime hours worked by the Detectives investigating child abuse cases during evenings and weekends.
- 4. The City and Multnomah County wish to extend the term of the agreement through June 30, 2011.
- 5. The maximum payment under this agreement shall not exceed \$64,000.

NOW, THEREFORE, the Council directs:

a. The Mayor and Auditor are hereby authorized to amend contract 30001158 between the City and Multhomah County in a form substantially in agreement with the attached in Exhibit A.

Section 2. The Council declares an emergency exists because delay in proceeding with this amendment will delay in billing under the agreement; Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
