FINDINGS OF FACT AND CONCLUSIONS OF LAW:

Mr. Charles Goldberg appeared at the hearing. Mr. Kurt Nelson, City of Portland Park Ranger, appeared as the City of Portland representative. The Hearings Officer admitted Exhibits 1 through and including 8.

During the hearing on March 18, 2011, Mr. Goldberg and Mr. Nelson requested an opportunity to engage in a discussion regarding a settlement. Mr. Goldberg and Mr. Nelson presented a proposed settlement agreement to the Hearings Officer (Exhibit 8). The Hearings Officer finds the representations and terms of the proposed settlement are reasonable and appropriate. The Hearings Officer adopts the proposed settlement as part of these findings and attaches Exhibit 8 to this Order.
