#### FINDINGS OF FACT AND CONCLUSIONS OF LAW:

Mr. Goldberg appeared at the hearing on March 18, 2011. Mr. Kurt Nelson, City of Portland Park Ranger, appeared at the hearing on March 18, 2011. The Hearings Officer admits Exhibits 1 through and including 9 into the evidentiary record. The Hearings Officer, with concurrence of Mr. Goldberg and Mr. Nelson, found that the Notice of Exclusion issued to Mr. Goldberg on February 22, 2011 was issued improperly. The Hearings Officer finds the Notice of Exclusion From City of Portland Park issued to Mr. Charles Goldberg on February 22, 2011 is not valid.

#### ORDER AND DETERMINATION:

- 1. The Notice of Exclusion From City of Portland Park issued to Mr. Charles Goldberg on February 22, 2011 is not valid; Appellant prevails in his appeal.
