Portland Plan Timeline







Equity Preamble

Definition

Equity is when everyone has access to opportunities necessary to satisfy essential needs, advance their well-being and achieve their full potential.



Equity Preamble

Foundational Role

- Equity is a central focus of all strategies and will be built into the objectives and actions.
- When reviewing each of the strategies, it is important to ask if equity issues are adequately and appropriately addressed



Why Equity Matters

- Prosperity:** We all win when everyone achieves their full potential.
- Resilience:** We need a prepared population to secure our future (have position in global economy, address climate change, etc).
- Prevention:** The cost of disparity is high (socially and fiscally).
- Ingenuity:** Build equity and accountability into business practices and tools.



Key Equity Elements of an Equity Agenda

- Closing the Gap
- Participation
- Equitable Public Spending
- Internal Accountability
- Partnerships



Equity Initiative

Purpose and Objectives:

- Reduce disparities across all plan areas, starting in an area where Portland lags
- Ensure accountability and implementation of the equity initiative
- Ensure that the City does business in an equitable manner.



Equity Initiative

Disparity Reduction Actions:

- Establish Office of Equity
- Develop tools
- Communication strategy
- Work With partners to identify what works
- Track spending patterns and levels of service

Accountability Actions:

- Collect and track data
- Examine budgets
- Early public involvement
- Advisory boards
- Leadership training
- Build equity objectives into youth services

Equity Initiative

Business Practice Actions:

- Civil rights laws + ADA
- Staff skill training
- Bureau/ agency plans
- Hiring and contracting
- Evaluate public information
- More coordinated translation services
