HEARINGS OFFICER'S ORDER

APPEAL OF GARY LANE

CASE NO. 3110124 [Police Bureau Case No. 11-23401]

PARK: Southwest Community Center

HEARINGS OFFICER: Mr. Gregory J. Frank

FINDINGS OF FACT AND CONCLUSIONS OF LAW:

On April 18, 2011 Portland Park Ranger Dezso submitted, via fax, a letter to the Hearings Officer (Exhibit 12). A hearing was scheduled for the purpose of considering Mr. Lane's appeal of a Notice of Exclusion from City of Portland Park dated March 18, 2011 (90 day exclusion from SW Community Center/Gabriel Park) (Exhibit 1b). The Hearings Officer admits Exhibits 1b and 12 into the evidentiary record.

Ranger Dezso, in Exhibit 12, states that the "Portland Parks Bureau wishes to withdrawal [sic] Lane's 90 day exclusion (Bureau Case # 1123401)." The Hearings Officer finds such request to be reasonable and appropriate. The Hearings Officer finds that the Notice of Exclusion from City of Portland Park dated March 18, 2011 issued to Mr. Gary Lane (Exhibit 1b) shall have no further force or effect. Mr. Lane's appeal hearing scheduled for April 21, 2011 at 4:00 p.m. in Room 3000 at 1900 SW Fourth Avenue, Portland, is cancelled.

ORDER AND DETERMINATION:

- 1. The Notice of Exclusion from City of Portland Park dated March 18, 2011 issued to Mr. Gary Lane (Exhibit 1b) shall be considered void and have no further force or effect.
- 2. Mr. Lane's appeal hearing scheduled for April 21, 2011 is cancelled.
- 3. This order has been mailed to the parties on April 19, 2011.

4. This order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.
