

ORDINANCE No. 007 184700

*Amend an Intergovernmental Agreement with the Oregon Department of Transportation and Multnomah County for SW Canyon Ct from the Zoo Interchange to the City Limits. (Ordinance; amend Contract No. 50604)

The City of Portland ordains:

Section 1. The Council finds:

1. The Oregon Department of Transportation, Multnomah County and City entered into a Cooperative Improvement and Abandonment Agreement No. 12082 (City Contract No. 50604) on March 8, 1995.
2. The Agreement covered the construction of the improvement in the Sunset Highway corridor and traffic management in conjunction with the Westside Light Rail work.
3. The three parties have determined that the above referenced Agreement shall be amended to clarify Project description, maintenance responsibilities, Project costs, and jurisdictional transfer limits for the purpose of completing jurisdictional transfers.
4. The Bureau's level of confidence in the cost estimates for this Project is not applicable as any cost associated with this agreement is the actual cost incurred on the Project.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and the Auditor are authorized to enter into an amended Intergovernmental Agreement with the Oregon Department of Transportation and Multnomah County, substantially in accordance with the agreement attached to the original of the ordinance.

Section 2. The Council declares that an emergency exists because the jurisdictional transfer between the parties is on hold until the City's acceptance of the IGA amendment; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
