

ORDINANCE NO. 184890

Authorize a Memorandum of Understanding between the Revenue Bureau and Worksystems, Inc. to implement the Youth Employment Credits authorized under PCC 7.02.880 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City Council passed Ordinance No 184716 on July 6, 2011, which established nonrefundable business license tax credits for youth employment for the 2011 and 2012 tax years.
2. PCC 7.02.882 requires that the City enter into an agreement or memorandum of understanding with a partner agency to act as the certifying agency for one of the youth credits established.
3. Worksystems, Inc. is willing and able to act as the certifying agency for both youth employment credits currently authorized for the 2011 and 2012 tax years under PCC 7.02.880.

NOW, THEREFORE, the Council directs:

- a. The Director of the Revenue Bureau is authorized and directed to execute on behalf of the City a Memorandum of Understanding with Worksystems, Inc. substantially similar to the document attached to this ordinance as Exhibit A.
