The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland, through its Portland Parks & Recreation (PP&R), owns property at 5200 NE Alberta, Portland, Oregon, 97218, comprising of approximately 2.43 acres, including an industrial warehouse and office building.
- 2. In 2009, PP&R purchased this property with a leaseback option to the seller so the seller's business could continue to use the property.
- 3. The existing tenant has requested additional time to vacate the property and has requested to extend the lease for one year with an option to extend for a second year.

NOW, THEREFORE, The Council Directs:

a. The Commissioner of Portland Parks & Recreation is authorized to execute a Lease Agreement with Werbin West Contracting, Inc. The Lease Agreement will be substantially similar to the attached and approved as to form by the City Attorney.

Section 2. The Council declares that an emergency exists in order to execute the lease in a timely manner for this City owned property; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
