184906 **ORDINANCE** No.

*Authorize Legal Service Agreement with McCool Smith PC. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Revenue Bureau intends to seek recovery of past due transient occupancy taxes, penalties, and interest owed by online travel companies.
- 2. The firm of McCool Smith PC has the necessary knowledge and skills to assist the City and its Revenue Bureau in the process necessary to recover those past due taxes, beginning with administrative hearings and proceeding through court litigation.
- Due to the nature of the work involved, McKool Smith has agreed to 3. represent the City in this matter on a contingency basis as outlined in the legal services agreement between the City and McKool Smith, hereby submitted as Exhibit A.

NOW, THEREFORE, the Council directs:

- a. The City Attorney and Chief Procurement Officer are hereby authorized to enter into a contract with McCool Smith PC in a form substantially in accordance with the agreement attached as Exhibit A, and to amend said agreement as required.
- b. If applicable, the provisions of City Code Chapter 5.68 are waived.
- Upon completion of the matter or as otherwise provided in the contract, c. the Auditor is authorized to draw and deliver warrants in payment of legal services and costs provided under this Legal Services Agreement.

Section 2. The Council declares that an emergency exists in order to allow Counsel to begin the legal processes to recover past due and delinquent monies owed the City in a timely manner; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
