

# ORDINANCE No. 184968

Renew contract with Centennial School District for Afterschool At-Risk Meal and Snack Program sponsorship (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Parks & Recreation is a sponsor of an Afterschool At-Risk Meal and Snack Program, administered by the Oregon Department of Education's Child Nutrition Program. Through this program, children enrolled in afterschool education or enrichment programs receive a free nutritious meals and snacks. Program sponsors are eligible for federal reimbursement of costs.
2. St. Johns Community Center and University Park Community Center are participating for the, 2011-2012 school year.
3. In 2010, City Council approved Portland Parks & Recreation's sponsorship of the program, and the Bureau entered into a sponsorship agreement with the Oregon Department of Education.
4. The Oregon Department of Education requires sponsors to annually renew their sponsorship.
5. Portland Parks & Recreation will provide these meals via a vended meal agreement with Centennial School District. This agreement is also renewed annually.
6. The 2011-2012 budget for this program is \$23,000, with \$21,000 projected in federal reimbursement monies.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept, on behalf of the City of Portland, a grant from the Oregon Department of Education for the Afterschool At-Risk Meal and Snack Program in the amount of \$21,000.
- b. The Director of Portland Parks & Recreation is hereby authorized to enter into a vended meal agreement with Centennial School District in a form substantially in accordance with the agreement attached as Exhibit A.
- c. The FY 2010/2011 budget is hereby amended as follows:
