*Ratify a Memorandum of Agreement with AFSCME Local 189 with respect to represented employee absences while participating in the Oregon non-profit organization called Start Making a Reader Today (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City and the Union are parties to a Collective Bargaining Agreement (CBA), the term of which is July 1, 2010 to June 30, 2013.
- 2. The CBA, Article 8.03, states, "Overtime rates shall apply to work performed by an employee before the regular starting time and after the regular quitting time of the shift on which that employee is regularly employed unless work performed outside the regular work day results from unpaid absence during the regular work day for personal reasons.
- 3. The City supports the mission of SMART. The mission of SMART is to help kids become confident readers by providing individual volunteer attention. As part of the City's support, the Bureau wants to provide an opportunity for represented employees to participate in the program during regular work hours without incurring overtime costs.
- 4. The City and the Union agree that represented employees may elect to take an unpaid absence to participate in the SMART program before or beyond their normal work shift. However, such employees are not eligible for overtime when they work before or beyond their normal work shift for purposes of participating in the SMART program.

NOW, THEREFORE, the Council directs:

a. The MOA between the City and AFSCME Local 189 attached as Exhibit A is hereby ratified by the Council.

Section 2. The Council declares that an emergency exists because delay would create problems in determining overtime pay; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
