### FINDINGS OF FACT AND CONCLUSIONS OF LAW:

Ms. Ellen Osoinach, Deputy City Attorney, appeared as the City of Portland representative. Mr. Barry Joe Stull, Appellant, appeared at the hearing and represented himself. The Hearings Officer admits Exhibits 1 through and including 11.

Ms. Osoinach, at the start of the hearing, requested that the Park Exclusion issued to Mr. Stull on November 6, 2011, be dismissed; the Park Exclusion would be considered not enforceable. Mr. Stull agreed with Ms. Osoinach's request to dismiss.

The Hearings Officer finds that the Notice of Exclusion From City of Portland Park (Exhibit 2) shall be considered invalid and therefore not enforceable.

#### ORDER AND DETERMINATION:

- 1. The Notice of Exclusion From City of Portland Park (Exhibit 2) issued to Mr. Barry Joe Stull on November 6, 2011, shall be considered invalid and therefore not enforceable.
