





Willamette River Recreation Strategy

- Focuses on priority projects & actions for next 15 years.







Resources for Shaping Strategy

- 2006 Water-based Recreation Report
- Consultations with Oregon State Marine Board and use of OSMB Triennial Boater Survey
- City of Portland River on-line surveys
 - 1,800 respondents
 - 2,500 comments
- 2 workshops



Public Comment / Responses

Strong agreement:

- *Important to serve full range of river recreation experiences*
- *Take care of the facilities we already have*
- *River recreation and river stewardship can and should work together.*

Revisions


- *River recreation roles*
 - OSMB, Coast Guard, Mult. Co. River Patrol, Portland Fire
 - Public organizations / private providers
- *Call out river safety more*
- *Clarify that recommendations benefit all users (user equity)*
- *More info on economic impacts*

Public Comment / Responses

Additional recreational desires...

- *More facilities than listed*
- *Greater engagement with private providers (marinas, clubs, businesses)*
- *More riverfront activation (“signature projects”, attractions, services)*

River Recreation Vision and Goals



Vision

A clean and healthy Willamette River is the pride of Portlanders who fish, paddle, sail, pleasure-boat, swim, experience nature, and sightsee on its waters.

Goals

- Increase Portlanders' enjoyment of, and direct experience with, the Willamette River.
- Bring people closer to the river to foster an improved understanding of river history, economy, and ecology.
- Manage recreation in concert with other City priorities to secure a net improvement in river health
- Provide for safe, enjoyable, and valuable on-water recreational experiences for all users.

Strategy Summary

- Portland's **PUBLIC** river recreation infrastructure:
 - inspired, but aging, patchwork of facilities...
 - ... built for different reasons,
 - ... at different times.
- To-date, there has been no unifying framework to:
 - guide City investment in maintenance, operations, or expansion;
 - help manage river user conflicts; or
 - track how Portlanders use, and want to use, the River.



Strategy Summary

- re-emphasizes City policy to encourage thoughtful recreational use of the Willamette;
- focuses primarily on public recreational boating and facilities ...;
- ... as a singular community asset that must be managed as a system;
- calls out the regional importance of river recreation in the Portland area
- puts a premium on taking care of the facilities we already have;
- targets a handful of new or expanded facilities in the next 15 years;
- emphasizes the need for new strategies and partnerships to fund improvements;
- establishes a river recreation advisory committee;
- establishes detailed guidelines for building boating facilities that minimize impacts to fish and wildlife habitat.

Environmental Guidelines (content)

- Integrate dock & facilities planning, citywide;
- Assure existing facilities are well-used before adding new;
- Document purpose/need for new facilities and alternatives considered;
- Avoid high-value habitat;
- Minimize impacts through design;
- Mitigate, inc. by removing overwater structures
 - City's 2011 G/S-based overwater structure inventory
 - Piling inventory on-going
- Public education

Environmental Guidelines (meaning)

- Getting people to the River is an important priority of the City of Portland.
- We're taking a very careful approach to in-water structures by:
 - making the best use of what we already have, and
 - planning just 3 new dock-related sites in the next 15 years
 - 2 of which are replacements
- When we do build docks, we will be rigorous in siting and design, using latest info from natural resource agencies.
 - This is our good faith effort to safeguard our river environment while meeting recreational demand...
 - ...and hopefully bodes well for improved program alignment.

Recommendations for next 5 to 15 years



Improve Existing Facilities

- *Willamette Park boat ramp:* dredge and repair toe ramp and debris boom
- Replace Swan Island boat ramp boarding float
- Renovate **Cathedral Park** boat ramp facility & implement Park Master Plan
- Replace dock at **Sellwood Riverfront Park**
- Repair **McCarthy Park's** non motorized river access path

Recommendations for next 5 to 15 years




Develop New Facilities for Anticipated Recreation Demands

- Replace Ankeny Dock in downtown Portland “By water” destinations
- Build a new dock in the South Waterfront District
- Explore SE Spokane Street light watercraft node
- Investigate Staff Jennings site for dock, beach launch, park
- Promote Waterfront Park “Hawthorne Bowl” beach access




Coordination & Education Needs

- Enhance waterway enforcement
- Improve education & recreation programs (inc. riverbank clean-up, safe boating & river stewardship).
- Get better information:
 - river use (demand, trends, recreation preferences);
 - river recreation economic impacts.
- Develop asset management plan; formulate partnership-based funding plan.
- Establish river recreation advisory committee.



Portland Plan

- 2035 Objective 7: ...All Portlanders can conveniently get to the Willamette and Columbia Rivers
- Connections for people, places, water and wildlife—Policy: Locate Neighborhood Greenways to ... make connections to ... the Willamette and Columbia Rivers.
- 5-Year Action Plan 26: Neighborhood greenways: ... connect every quadrant of the city to the Willamette River.
- Coordinated Inter-agency Approach—Policy: Plan and invest in active transportation, parks and recreation, public infrastructure, watershed health ... creating this network will require: ...
 - Maintenance and preservation of existing transportation, park and recreation, and stormwater infrastructure,...
 - Continued and expanded support of ... initiatives that support a vibrant network, **environmental stewardship**, and that encourage people to walk, bike and take transit, **recreate**, and make other healthy choices.



