Subject: Reappointments to the Development Review Advisory Committee (DRAC)

Portland City Code Title 3.30.030 specifies that members of the Development Review Advisory Committee (DRAC) may serve up to two 3-year terms. Several current DRAC members are completing their first terms or partial terms (served for prior members who resigned), and are eligible for reappointment. They have all expressed interest in continuing on the DRAC and have completed the required interest form. The table below lists the members eligible for reappointment, along with their DRAC position and status:
