PBEM and Portland Fire & Rescue (PF&R) coordinate the NET (Neighborhood Emergency Teams) program. NET members are residents trained by PBEM and PF&R to provide emergency disaster assistance within their neighborhoods. NET members receive basic training (Community Emergency Response Team) on how to save lives and property until emergency responders can arrive. They have the skills to help their neighbors without getting hurt themselves.

Ongoing dissatisfaction about the program and interpersonal conflict among NET members prompted a need for mediation and consultant services. After case development, interviews with NET members and program administrators, Resolutions Northwest will develop recommendations for how to improve NET leadership, governance and process, communications and relationship with PBEM.

PBEM's original estimates of how much time this would take and how much work was to be involved turned out to be inadequate. After initial meetings with NET members, Resolutions Northwest determined that much more time and effort would be required.
