1,400 REASONS TO KEEP VOTER-OWNED ELECTIONS

Transit Riders Union presented 1,400 signatures on petitions to the TriMet Board (an unelected body) against fare hikes & service cuts. The board voted 6-1 to implement the cuts and fare hike, regardless!

It is currently 'illegal' for voters to vote to elect the TriMet board (TRU is preparing an initiative petition to change this). While keeping VOE for the city of Portland council races won't extend VOE to Metro elections or TriMet, it is important to keep it in place now – so low-income folks and others disenfranchised groups have a chance to penetrate the current Election Industry (esp. w/Citizens United).



BOYCOTT REEDVILLE CAFÉ TO ELECT THE TRIMET BOARD & STOP THE CUTS & FARE HIKES

Since we can't "vote" for the TriMet board, we can cast an 'economic' vote by boycotting the Reedville Café – which is owned by TriMet board president Rick Van Beveren. Van Beveren has voted for every fare hike and service cut in the past two years. TriMet Gen. Mgr. Neil MacFarland (who makes \$200,000 per year) says transit riders should 'be patient & wait' till the economy gets better for service cuts and fare hikes to (possibly) be rescinded.

BOYCOTT REEDVILLE CAFE

Transit Riders Union, over the past year, has collected and presented the TriMet board of directors with 1,400 signatures on petitions against bus and MAX service cutbacks and against fare hikes. Lynn Lehrback, a Teamsters representative on the TriMet board dissented, but the board voted to disregard transit riders completely and cutback 60 bus routes, decrease MAX frequency, and implement two fare hikes. This at a time when Oregon's economy and unemployment rate are among the five worst states in the nation, and when workers and students alike need to be able to get to jobs, classes, job interviews, and doctor appointments.

TriMet's unelected board of directors (and staff) are deserting TriMet, in 2010, like rats deserting a sinking ship. Fred Hansen, TriMet's longtime, \$250,000 per year General Manager, quit this spring. Steve Banta, TriMet's Operations Director, after meeting with five organizers from Transit Riders Union, quit TriMet this year and moved to work for the Phoenix, Arizona, transit system.

Over half the unelected TriMet board has quit this year, as well. George Passadore, former regional president of Wells Fargo Bank, was the 13 year TriMet board president, and Passadore, following protest after protest against the so-called austerity budget cuts and fare hikes -- quit the board in May, 2010. Bob Williams, a TriMet board member known to transit activists as 'the Butcher of Fareless Square' (he proudly told transit riders that he pushed for gutting Fareless Square in 2008, and finally succeeded, in January, 2010, in gutting Fareless Square) -- quit_{TR} to hold TriMet accountable and have the

the TriMet board in 2010 as soon as the cutbacks to Fareless Square were implemented.

The new TriMet board president, Rick Van Beveran, was the vice president of the board and has voted, over the past two years, for every fare increase and every bus and MAX service cut. Several bus lines have been eliminated altogether. Other buses have lost weekend service altogether. MAX frequency has been cut back even as TriMet keeps building more light rail lines. Van Beveran also owns the Reedville Cafe in Hillsboro, on the #57 bus line.

Due to TriMet's utter disregard for transit riders over the past two years, Transit Riders Union is organizing the Reedville Cafe Boycott to elect the TriMet Board. One of the main underlying problems with TriMet is that the board is appointed, in secret, by Oregon's governor, with zero transparency or input from transit riders or the community. Metro, according to Robert Liberty, an elected Metro councilor, has the power now, via ORS (Oregon Revised Statutes) to take over TriMet. An initiative petition can also be used to place a ballot measure before voters in an Oregon election, calling on voters to approve requiring that the TriMet board be elected by the people. These are longterm projects of Transit Riders Union.

But the TriMet board continues. unabated, to cut services and raise fares. The time for activists and radicals at the grassroots level to take action is now, including supporting and spreading the word about the Reedsville Cafe Boycott, as well as organizing a picketing campaign

TriMet board elected.

Transit Riders Union has already held one picket at Portland Business Alliance in downtown Portland, and is planning more pickets, both at PBA and at the Reedville Cafe (which is easily accessible via MAX and the #57 bus). TriMet's overall argument about what activists call TriMet's "transit shock doctrine" is that they have no money to keep funding buses, MAX frequency, Fareless Square, or to keep fares economical. Yet TriMet has a \$2.5 billion budget, including capital projects. A second, strawman argument TriMet uses is that federal funding guidelines support light rail funding at the expense of bus funding -- and buses tend to be used by the poor, homeless, workers, students, seniors, disabled folks, etc. This is a specious argument in that transit activists in Los Angeles and San Francisco -- via three federal court suits and injunctions -- have been able to: (a) halt a fare hike with 10 minutes to go in LA, (b) reverse \$70,000,000 in funds set for light rail and redirect to bus funding in SF, and (c) halt light rail funding for 5 years in LA and require the MTA there to purchase 500 buses.

Transit Riders Union, in this case, is not calling for a boycott like Dr. King's Montgomery bus boycot. Many unemployed and low-income Oregonians, and many bus riders, need to use the bus to get to work and to the store. However, the targeted, specific Reedville Cafe Boycott to Elect the TriMet Board is a strategic

opportunity to force TriMet to live up to their marketing image of being liberal and progressive. It is unacceptable, for example, that the driver who ran over five people, killing two women pedestrians in their 20s, on the #9 bus downtown, still works for TriMet. For a safe and economical transit system, please support the Reedsville Cafe Boycott!

Moreover, transit organizers note that when Tom Hughes, the Oregonianand Tribune- anointed candidate for Metro president in the upcoming November runoff election against former 1,000 Friends of Oregon directo Bob Stacey, he'd the Hughes Primary Election Victory Party -- it was held at the Reedville Cafe in Hillsboro. Not only does Hughes support the CRC bridge, while Stacey opposes CRC, but Hughes has been asked whether he supports having the TriMet board elected by the people, and Hughes says "no." Hughes, like Reedville Cafe owner and current TriMet board president Rick Van Beveran, favors keeping the TriMet board unelected -- and unaccountable.

For something as important as transit, ecology, fighting global warming, preserving air quality, stopping dependence on foreign oil and wars for foreign oil -- it is time to put a little democracy into the TriMet power structure. Even the East Multnomah County Soil & Water Conservation District is an elected body. It is time to take our transit back -- Boycott Reedville Cafe!

Officer convicted of lesser charge in death

A white former transit officer was convicted of involuntary manslaughter Thursday in the shooting death of an unarmed African American man on an Oakland train platform in a 2009 encounter that set off days of rioting in the city.

Prosecutors had hoped Johannes Mehserle would be convicted of murder in the deathof 22-year-old Oscar Grant, who was shot as he lay face down.

TRIMET'S PUPPET BOARD OF DIRECTORS

When TRU organizers met with outgoing Ops Mgr Steve Banta (2010), Banta noted the appointed TriMet board had NEVER worked with staff to look for alternate funding sources. TRU is doing this. TriMet has, per WWeek, a \$2.5 billion budget, counting capital projects. The 2010 fare hike will only raise \$1.5 million of an alleged \$27 million shortfall. That \$\$\$ can be found elsewhere

Calling all lawyers. Portland's Transit Riders Union (trime ers.org) is in the market for an attorney to help it see court injunction that would halt the

elimination of Fareless Square for buses starting Jan. 3. Meantime, the transit advocacy group plans to protest at 9 am on Wednesday, Dec. 30, at 200 SW Market St., outside the Portland Business Alliance, which backed the change to rail-only Fareless Square.



Cutting bus service and MA frequency (while building more light rail) guts a transi system. In LA and SF, transit activists have won a fare hike halt (with 10 minutes to go) via a court injunction, and stopped rail construction for five years & got MTA in LA to buy 500 buses via a 2nd court injunction.

MORE PICKETS AT PORTLAND BUSINESS ALLIANCE

Bernie Bottomly, VP of the PBA, pushed TriMet for years to gut Fareless Square. TRU picketed PBA and will do so again.



As with pushing for sit-lie (to marginalize and criminalize the homeless) PBA and the Oregonian want downtown PDX to be a tourist mecca, with the working poor & others 'out of sight & out of mind.' TRU rejects this!

For now, TriMet board president Steve Van Beveren owns the Reedville Café & has voted for every service cut & every fare increase in past two years.

Reedville Café was site of the May primary election victory party of conservative Metro president candidate Tom Hughes—who is endorsed by Oregonian & Tribune.



Portland Business Alliance donated \$5,000 in July, 2010 to the pro-CRC Metro president candidate Tom Hughes.

Hughes supports the CRC and opposes (as does Van Beveren) having the TriMet Board elected. Bob Stacey, the progressive candidate for Metro president, opposes the CRC. Hughes & Stacey face each other in the November election.

Since bus riders need transit to job-hunt, get to work, school, the doctor, etc., a Dr. King-style bus boycott won't work in the worst recession since the 1930s. By boycotting the Reedville Café, however, we are saying "no" to TriMet's fare hikes, service cuts and lack of democracy and transparency.

ACCOUNTABILITY FOR TRIMET

The Transit Riders Union opposes the proposed 5-cent fare hike by TriMet [see "End of the Line," *WW*, Feb. 17, 2010], as well as the cuts to over 60 bus routes. As the TriMet board is unelected (but appointed by Oregon's governor), this is the third proposed cutbacks to bus service—with zero accountability to transit riders and the community alike.

The TriMet board is appointed in secret, by Oregon's governon A 2010 appointment to the TriMet board is Steve Clark, Portland Tribune president. The Tribune has endorsed Tom Hughes for Metro president. It is time to take our transit back!

Transit Riders Union will work for an immediat halt to this "transit shock doctrine," as well as more long-tern funding and democracy solutions. Stop the cuts and elect th TriMet board!
