Why Request a Waiver to LT2 Rule? Because It Makes Good Sense and Cents

A rationale for supporting a robust effort by the Portland City Council in requesting a LT2 Waiver December 5, 2010

INTRODUCTION: I moved to Portland three years ago and was impressed with the quality of the drinking water. Over the years I became concerned about the rapid increase in my water bills and the calls for attention to an impending change to the Bull Run water supply system including the covering/abandoning of the existing open reservoirs. I have attended two town hall meetings, read extensively on background materials on the Portland Water Bureau website as well as the Friends of the Reservoirs website. I have come to the conclusion that treating our Bull Run water and covering the existing reservoirs do not make cents or sense. Therefore I strongly recommend that the Portland City Council pursue administrative and legislative waivers to the LT2 Rule and allow the open reservoirs to remain uncovered with the addition of state-of-the-art security system upgrades.

Our Bull Run water system is now an organic, pure, sustainable, unfiltered system. This system works well for us and is not broken.

- 1. The Bull Run water system is a gift from our forefathers.
- 2. The Bull Run water system was well-planned, is passing the test-of-time, and should not be radically modified.

THEREFORE, THE PROPOSED CHANGES DO NOT MAKE SENSE

The public is starting to reach the tipping point in regard to paying for essential services.

- 1. I have recently talked with an elder citizen forced to put his most recent water bill on his credit card due to the increase in rates. A single Mom with two children will lose her house when the cost of essential services increases unabated.
- 2. The citizens of Portland have an excellent record of financially supporting improved essential services such as the Portland Community College Bond issue. The public schools also need attention and the Portland Public Schools are bringing a large bond issue to its constituents this spring. The middle class and working poor cannot afford supporting projects that do not have value such as the LT2 driven water system modifications.
- 3. The cost-benefit does not warrant the remedy to problems that do not exist.
