## ORDINANCE No. 185270

\* Authorize a grant agreement with World Affairs Council of Oregon to provide \$34,700 to help pay for costs associated with its Global Classroom programs (Ordinance)

## The City of Portland ordains:

Section 1. The Council finds that:

- 1. The city of Portland recognizes that the World Affairs Council of Oregon has been an important asset for internationalization of this community since 1950. For decades, the World Affairs Council has led the state and the City of Portland in providing educational programs, public discussion, study opportunities, and professional training programs designed to enhance international awareness; and
- 2. City Council supported the allocation of \$34,700 in the FY 2011-12 Adopted Budget to provide the World Affairs Council of Oregon financial assistance to implement their Global Classroom program which will: target Portland-area schools to enhance international education; train teachers on how to provide international content in their classrooms; and help K-12 students advance critical learning in international affairs, economics, history, culture, current events and more; and
- 3. The City recognizes the mission of the Society to broaden public awareness and understanding of international affairs and to engage Oregonians with the world.

## NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to enter into a Grant Agreement, as outlined in form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$34,700.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrant chargeable to the FY 2011-12 Education Budget when demand is presented and properly approved by the proper authority.

Section 2. The Council declares that an emergency exists because any delay in providing grant funding to World Affairs Council of Oregon would harm the public interest; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
