ORDINANCE No. 185304

Rename the Portland Office of Emergency Management to the Portland Bureau of Emergency Management (Ordinance; amend Code Chapters 3.124, 3.125, 3.126 and Code Section 2.12.020 and 15.08.010)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Council Resolution 36881, passed on September 21, 2011, directed an ordinance to be drafted changing the name of the Portland Office of Emergency Management to the Portland Bureau of Emergency Management (PBEM).
- 2. Changing the bureau's name is consistent with the stature and authority of the bureau, as well as being consistent with the naming convention of City bureaus.
- 3. The renamed Portland Bureau of Emergency Management should be substituted for the Portland Office of Emergency Management throughout City Code or City Policy documents wherever necessary to provide consistency in official City references.
- 4. Code Section 15.08.010 is also being amended to clarify succession in the event of an emergency.

NOW, THEREFORE, the Council directs:

- a. The Portland Bureau of Emergency Management is created as the new name of the previously named Portland Office of Emergency Management.
- b. Amendments to Portland City Code Chapters 3.124, 3.125, 3.126 and Code Section 2.12.020 and 15.08.010 are hereby adopted, as set forth in Exhibit A attached to this Ordinance.
- c. In accordance with Portland City Code 1.01.035.C and 1.07.060.A, the Auditor may substitute PBEM's new name in place of the current name wherever the bureau is referred to in the Portland City Code and Policy Documents.
