To my colleagues:

As chair of the Rose Quarter Development Project Stakeholder Advisory Committee (SAC), I am pleased to present to you the results of the group's deliberations. Representatives of the SAC will present to council on March 11, further explaining their recommendation.

In short, the SAC recommends that the Portland City Council ask the Portland Development Commission to act as its agent and issue a Request for Proposals to the following concept teams:

- **Veterans Memorial Arts and Athletic Center (VMAAC)**
- **Memorial Athletic Recreation Center (MARC)**
- **Trail Blazers and Winterhawks Concept**

The SAC also designated two alternates, should any of the above teams choose not to participate in the RFP. The alternates are:

- **Rose Quarter Community Crossroads** (first position)
- **Portland Action Sports Complex** (second position)

I look forward to sharing an update on this project on March 11, and to moving toward the formal Proposals phase, as we seek to determine the future use of the Memorial Coliseum.
