2) Purpose of the Proposed Legislation: Updates Portland Policy Document regarding Transportation Fees and Charges effective July 1, 2012 in accordance with the City's Approved Budget, adds Code language to 17.40 to allow disposition of recycled materials at Sunderland Yard, and amends code 16.20.900 to allow the Transportation Director rate-setting authority for City-owned parking garages under certain specific provisions.
