

ORDINANCE No. 185387

* Authorize contract with Moore Iacofano Goltsman, Inc. in the amount of \$219,114 to provide consultant services for Redevelopment of the ADA Title II Transition Plan for the City (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. RFP No. FAC020 for a consultant to provide consultant services for Redevelopment of the ADA Title II Transition Plan for the City of Portland was issued December 2011. Five proposals were received on January 27, 2012. A selection committee reviewed the proposals and selected Moore Iacofano Goltsman, Inc. to recommend for contract award. The contract amount is \$219,114 with an expiration date of December 31, 2013.
2. The City of Portland's Facilities Services Division recommends this contract be approved substantially in conformance with Exhibit A attached.

NOW THEREFORE, the Council directs:

- a. The Chief Procurement Officer and Auditor are hereby authorized to enter into a contract, substantially in conformance with Exhibit A attached, with Moore Iacofano Goltsman, Inc. for consultant services for Redevelopment of the ADA Title II Transition Plan for the City of Portland not to exceed \$219,114.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks payable to Moore Iacofano Goltsman, Inc. when demand is presented and approved by the proper authorities.

SECTION 2. The Council declares that an emergency exists to avoid a delay in proceeding with the contract; therefore, ordinance shall be in full force and effect from and after its passage by Council.
