Dear Portland City Council,

I am writing to express my severe concern about two abandoned, damaged, rundown properties located at 10840 and 10848 SE Salmon St., Portland Oregon. These two "homes" are located extremely close to Floyd Light Middle School, which educates over 800 12-14 year old students. Unfortunately, many of our kids are aware of these structures and we have dealt with a variety of unhealthy and crime related issues committed on or close to the properties. In particular, arson, drugs, alcohol, and sex have all been rumored to take place in these disgusting properties and are regularly talked about by our students. Recently, an arson investigator stopped by to question several of our kids due to some fire setting in one of the properties. Several of our students have their names carved or tagged on the outside, which is an indicator that they frequent the area.

We have been battling absenteeism, truancy, and a variety of other social issues especially with our high-risk students. Having these uninhabited properties in such an isolated setting is enticing to some of these kids, and is a danger to anyone who enters them. I am an educator and not familiar with the political or legal processes that need to be followed for demolition. In an effort to protect our kids, I implore you to pursue the removal of these unsafe, disgusting, derelict houses.
