

**ORDINANCE No. 185419**

\*Authorize an Intergovernmental Agreement with the State of Oregon on behalf of Portland State University, for the use of parking permits and access cards at the 4<sup>th</sup> Avenue Garage and provide for payment (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Development Services (BDS), Bureau of Environmental Services (BES) and the Portland Bureau of Transportation (PBOT), collectively, COP, has a need for parking spaces and access cards at the 4<sup>th</sup> Avenue Garage. BDS, BES and PBOT inspection staff's City assigned vehicles have a need to park in the garage. BES and PBOT utilize personal vehicles in order to conduct field inspections.
2. The BDS inspection staff has parked in PSU's 4<sup>th</sup> Avenue Garage parking facility which is adjacent to the Development Services Building since BDS moved into the Development Services Building in 1999. BES and PBOT staff that are located at the 1900 Building also have a need to park City assigned and personal vehicles in the garage in order to conduct field inspections in a timely manner. The parking structure is the most convenient and efficient in terms of access and proximity to the Development Services Building.
3. Historically, the Bureau of Development Services has had and currently has an interagency with BES and PBOT to handle and process all of the parking invoices and customer service issues between Portland State University Transportation and Parking Services and BES and PBOT.
4. The cost for BDS will be \$155 per permit per vehicle per month and \$165 for BES and PBOT as their vehicles do not leave the parking structure as frequently.
5. Funds for this IGA are available in the BDS, BES and PBOT's FY2012-13 budget.

NOW, THEREFORE, the Council directs:

- a. The Commissioners-in-Charge are authorized to enter into an IGA with the State of Oregon, acting by and through the State Board of Higher Education, on behalf of Portland State University (PSU), Transportation and Parking in a form substantially in accordance attached as Exhibit A.
- b. The Parking Agreement as described in Exhibit A shall be in effect July 1, 2012 and ending on June 30, 2013.

- c. The Mayor and the City Auditor are hereby authorized to pay for said IGA from the FY2012-13 Bureau of Development Services Budget, Account 544000, various cost centers, when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists in order to prevent delays in timely payment to PSU; this ordinance shall be in force and effect from and after its passage by Council.
