

ORDINANCE No. 185449

Update Solid Waste and Recycling Collection Code to extend the timeline for clean fleet collection vehicle replacement by two years and allow greater flexibility in meeting the timelines (Ordinance; replace Code Section 17.102.050)

The City of Portland Ordains:

Section 1. The Council Finds:

1. Chapter 17.102 is the means by which the City complies with the statutory directives that encourage waste prevention and recycling. Portland carries out these efforts through residential franchising, issuing permits to commercial waste hauling companies, and requiring all businesses to recycle.
2. In September 2008, the Council adopted Ordinance 182190 establishing clean fleet requirements for waste hauling companies including requirements for fuel use and truck replacement.
3. The Code amendments in this Ordinance include a) extending the timeline for residential collection vehicles to come into compliance with the fleet replacement requirement from January 2014 to January 2016, b) allowing collection vehicles retrofitted with a diesel particulate filter through a Metro grant-funded program to be replaced at a later date, and c) allowing garbage and recycling companies to propose a schedule for meeting vehicle replacement timelines.

NOW THEREFORE, the Council directs:

- a. Portland City Code Chapter 17.102.050 is replaced as set forth in Exhibit A.
