ORDINANCE No. 185461

Extend the term to issue short-term subordinate urban renewal and redevelopment bonds (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland adopted Ordinance No. 180963, amended and restated by Ordinance No. 182475 and amended by Ordinance No. 184514 (collectively the "Amended Ordinance") to authorize short-term subordinate urban renewal and redevelopment bonds.
- 2: The authority of the Amended Ordinance expired on May 23, 2012 and the City of Portland finds it desirable to extend that authority through the end of Fiscal Year 2012.

NOW, THEREFORE, the Council directs:

The City hereby amends the Amended Ordinance to authorize the issuance of short-term a. subordinate urban renewal and redevelopment bonds through the end of Fiscal Year 2012. All other provisions of the Amended Ordinance shall remain in effect.

Section 2. The Council declares that an emergency exists in order that short-term subordinate urban renewal and redevelopment bonds may be issued as soon as possible; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
