

ORDINANCE No. 185542

*Amend Legal Services Agreement with Radler White Parks & Alexander LLP for outside counsel related to the Veterans Memorial Coliseum. (Ordinance; amend Contract No. 30002709)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland Development Commission ("PDC"), the City of Portland, and Radler White Parks & Alexander LLP ("Counsel") are parties to a Legal Services Agreement under which Counsel provides legal services to the City of Portland related to the renovation of Veterans Memorial Coliseum and PDC, as a grant to the City of Portland, covers the cost of such services up to a current maximum amount of \$375,000.
2. The cost of legal services to the City of Portland for the renovation of Veterans Memorial Coliseum is anticipated to exceed the current grant of \$375,000, by approximately \$235,000, requiring an amendment to the Legal Services Agreement to increase PDC's grant to \$610,000.
3. On August 15, 2012, the Portland Development Commission approved Resolution No. 6960 authorizing the increased grant.
4. All payments for legal services provided under the Second Amendment to the Legal Services Agreement will be made by the Portland Development Commission.

NOW, THEREFORE, the Council directs:

- a. The City Attorney and Chief Procurement Officer are authorized to amend Legal Service Agreement No. 30002709 (formerly Agreement No. 30002278), which provides representation by outside counsel, in an additional amount of \$235,000, bringing the total amount of this contract to \$610,000. (Amendment attached as Exhibit 1.)
- b. If applicable, the provisions of City Code Chapter 5.68 are waived.

Section 2. The Council declares that an emergency exists to pay for legal services necessary in the matter of the renovation of the Veterans Memorial Coliseum; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
