a) What impacts are anticipated in the community from this proposed Council item?

This ordinance seeks Council approval for the hiring of a consulting team to assist the City and its regional partners with design, conduct, and evaluation of a regional disaster exercise. Hiring of the team and the work it performs will have little impact on the community other than to provide assistance to the many organizations planning the exercise. However, the exercise itself will involve and impact numerous external government entities (state, county, city, special district), several volunteer groups and NGOs (NET, Medical Reserve Corps, Amateur Radio Emergency Services, American Red Cross), hospitals, and, perhaps, a number of large private sector entities in the region.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

A wide spectrum of external government entities (city, county, state, special district and National Guard), along with representatives from the healthcare industry, regional utilities, the American Red Cross, and others were involved in developing the initial goals and objectives for the regional exercise. A smaller group representing those same organizations has been formed to design the exercise and this group will work with the consulting team identified in this ordinance.

c) How did public involvement shape the outcome of this Council item?

Public involvement shaped the initial exercise goals and objectives and helped identify public/ community expectations for both the exercise and the exercise design process. The goals, objectives, and expectations were factored into the RFP that led to selection of the consulting team identified in this ordinance.

d) Who designed and implemented the public involvement related to this Council item?

The initial public involvement strategy was developed by a small team with representatives from the City (fire and emergency management), the regional Cities Readiness Initiative (public health), and Washington County (emergency management). Since formation of the regional exercise design team, the public involvement strategy has

been managed by that group. The exercise design team includes the same people who were part of the initial team plus representatives from the five counties in the metro area, state government (health and emergency management), law enforcement, fire, public safety communications, the Red Cross, hospitals, and more.
