The City of Portland ordains:

Section 1. The Council finds:

- 1. QBS/RFP No. FAC022 for a consultant to provide architectural and engineering services to remodel buildings for a Police Training Center Complex was issued May 21 2012. Seven proposals were received on June 20, 2012. A selection committee reviewed the proposals and selected Scott Edwards Architecture, LLC to recommend for contract award. The contract amount is \$499,748 with an expiration date of December 31, 2014. Scott Edwards Architecture, LLC is locally owned and operated. State-certified MWESB subconsultant utilization on this project is 36.5%.
- 2. The City of Portland's Facilities Services Division recommends this contract be approved substantially in conformance with Attachment No. 1 attached.

NOW THEREFORE, the Council directs:

- a. The Chief Procurement Officer and Auditor are hereby authorized to enter into a contract, substantially in conformance with Attachment No. 1 attached, with Scott Edwards Architecture, LLC for a consultant to provide architectural and engineering services to remodel buildings for a Police Training Center Complex not to exceed \$499,748.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks payable to Scott Edwards Architecture, LLC when demand is presented and approved by the proper authorities.

SECTION 2. The Council declares that an emergency exists to avoid a delay in proceeding with the contract; therefore, ordinance shall be in full force and effect from and after its passage by Council.
