Authorize an Intergovernmental Agreement with Portland Public Schools for Installation of Water Efficiency Devices (Ordinance)

2) Purpose of the Proposed Legislation: Authorize an Intergovernmental Agreement with Portland Public Schools for Installation of Water Efficiency Devices.

The Portland Water Bureau (PWB), through the Water Efficiency Program, provides water conservation information and technical resources to help customers use water efficiently and cost-effectively. The efficiency program coordinates several successful partnerships and programs including education and outreach, technical assistance and retrofit/replacement programs such as the conservation device distribution program.

Over the years, the PWB's Water Efficiency Program has worked closely with Portland Public Schools (PPS) to help them reduce their water use and become more efficient so that more funds are freed up to support education of Portland-area students. This IGA would help PPS reduce more use by assisting them in replacing water-cooled equipment with air-cooled equipment, eliminate any single pass cooling, and/or replace high water use fixtures with more efficient ones. Not only will this save them water, but energy as well as new air-cooled equipment is far more efficient in energy use than the old water-cooled equipment. In these trying times for educational institutions, and the City's continued efforts to support PPS in their efforts to educate Portland students, assisting them to become more water efficient is the right thing to do.
